ORDER DIRECTING STATUS REPORT

On August 17, 2020, The Empire District Electric Company, a Liberty Utilities company ("Liberty-Empire"), on behalf of Liberty-Empire, the Staff of the Commission and the Office of the Public Counsel (OPC), filed a *Motion to Suspend Procedural Schedule*. The motion advised the parties had reached a settlement "in principle" and the parties intended to file a written settlement agreement by September 1, 2020.

On August 18, 2020, the Commission suspended the procedural schedule and ordered the parties to file a status report no later than September 1, 2020. On September 1, 2020, Liberty-Empire filed a status report indicating the parties continue to work together on settlement language and intend to file a written settlement agreement "shortly." The report also indicates Liberty-Empire does not anticipate filing revised tariff sheets in this proceeding.

Because Liberty-Empire reports settlement discussions are underway, the Commission will direct the parties to file monthly status reports until a proposed settlement agreement is filed or until further order.

THE COMMISSION ORDERS THAT:

1. The parties shall file a monthly status report no later than the fifth day of each month, beginning in October, until a proposed settlement agreement is filed in this matter or until further order.
2. This order shall be effective when issued.
