#### ORDER DIRECTING FILING

On August 27, 2020, the parties met for a prehearing conference. During the conference, the regulatory law judge requested the parties file a joint procedural schedule. During the hearing, the judge requested that Staff file a proposed procedural schedule, or provide a status report, no later than September 3, 2020.

On September 3, 2020, Staff counsel advised, via e-mail copied to all parties, that the parties have consulted about a procedural schedule, but Staff counsel has been unable to confirm a final submission with the Complainant, Mr. Scott.

The Commission will order Staff to file a proposed procedural schedule that reflects the parties' agreement and discussions as of the time of filing.

#### THE COMMISSION ORDERS THAT:

1. Staff shall file a proposed procedural schedule no later than September 10, 2020, indicating the extent to which the parties were able to agree on a schedule. If Staff is unable to confirm a joint proposal with Mr. Scott, Staff's filing shall state the parties' attempts to contact Complainant.
