**AFFIDAVIT OF ADMINISTRATIVE ESTOPPEL, TACIT ADMISSION, AND
EQUITABLE STANDING OF TRUSTEE**

I, Robert L. Davis Jr., being duly sworn under penalty of perjury pursuant to 28 U.S.C. § 1746 and applicable Missouri law, declare and affirm the following:

- 1. Trustee Capacity:** I am the duly authorized and acting Trustee for Musiqaa Rayiys Bey PLT, a private ecclesiastical trust established under ecclesiastical, common, and private trust law. I make this declaration in my equitable capacity, not as a licensed attorney, but as a fiduciary and private administrator for the Trust.
- 2. Publication of Administrative Fault:** A verified *Notice of Estoppel, Non-Response, and Administrative Fault* was submitted for publication in a newspaper of record (The Daily Record) and is currently pending publication to the public record, concerning unresolved claims against Spire Missouri Inc., a regulated utility, for improper billing and mishandling of tariff-related trust securities.
- 3. Tacit Admission & Estoppel by Silence:** Said notice followed multiple verified and un rebutted demands, in which Spire Missouri Inc. and associated agents failed to timely respond, cure, or rebut the claims presented therein. Their silence constitutes:

- Tacit admission to the material facts presented;
 - Commercial and administrative default;
 - Waiver of rights, immunities, and defenses;
 - Estoppel by acquiescence and silence;
 - Failure to honor tendered financial instruments in commerce and equity.
4. **Equity Jurisdiction Preserved:** This affidavit serves to preserve the standing of the Trust and the undersigned as Trustee to act in equity and to secure the record administratively and judicially. The pending publication further operates as constructive notice and cure of record for the public and any lawful forum, including this appellate court.
5. **Supplemental Filing for Judicial Record:** This affidavit is submitted as part of the appellate record to demonstrate continuing equity standing, ongoing administrative diligence, and to prevent waiver or dismissal based on legal technicality, gatekeeping, or mischaracterization of the Trust's ecclesiastical structure.
6. **Good Faith and Truthful Intent:** This filing is made in good faith and for the purpose of preserving rights, securing remedy, and affirming lawful notice to all relevant parties.
