#### ORDER DIRECTING FILING

On May 27, 2020,<sup>1</sup> the applicants filed their Application for Authority to Sell or Transfer Assets and Application for Approval of a Territorial and Exchange Agreement and on July 15, they filed a Supplement to Joint Application. On June 11, the Commission ordered Staff to file a pleading stating when it anticipated filing a recommendation, and on July 17, the Staff complied, advising it anticipated filing a recommendation by September 18. On June 17, 2020, the Commission ordered Staff to do so.

The law requires the Commission to rule on the Application no later than 120 days from its filing date,<sup>2</sup> i.e., no later than September 24. In the interests of administrative efficiency, the Commission will order the parties to file any objection to the Commission's extending the deadline for the Commission action to November 23.

#### THE COMMISSION ORDERS THAT:

- 1. Any party objecting to the Commission extending the deadline for the Commission's ruling on the Application to November 23, 2020, shall file the objection no later than 9 a.m. on September 14, 2020.
  - 2. This order shall be effective when issued.
