**STATUS REPORT**

**COMES NOW**, Evergy Metro, Inc. d/b/a Evergy Missouri Metro (“Evergy Missouri Metro”) and Evergy Missouri West, Inc. d/b/a Evergy Missouri West (“Evergy Missouri West”) (collectively, “Evergy” or the “Company”) and states as follows:

1. In its *Order Requesting Procedural Schedule or Status Report*, the Missouri Public Service Commission (“Commission”) directed the Parties<sup>1</sup> to file a procedural schedule or a status report by July 7, 2025.

2. On July 7, 2025, Staff, after discussion with the Parties, filed a *Status Report* requesting additional time until July 15, 2025, so the Parties could continue discussing a settlement.

3. On July 15, 2025, the Company, after discussion with the Parties, filed another *Status Report* requesting additional time until July 22, 2025, so the Parties could continue discussing a settlement. That request was granted by the Commission on July 18, 2025.

4. The Parties have reached a settlement in principle; however, the corresponding tariff changes are still being drafted. Because tariff drafting is ongoing, the Parties request the Commission grant another week to finalize the tariff edits so both settlement and the corresponding tariffs can be filed at the same time.

5. The Parties request the Commission grant another week extension until July 29, 2025, to file the unanimous settlement and corresponding tariffs.
