ORDER GRANTING ADDITIONAL TIME

Issue Date: July 23, 2025

Evergy Metro, Inc. d/b/a Evergy Missouri Metro and Evergy Missouri West, Inc. d/b/a Evergy Missouri West (Evergy) filed a request for a waiver of various Chapter 13 Regulations on January 17, 2025. On February 6, 2025, the Commission directed Staff to file a recommendation no later than March 6, 2025. On March 5, 2025, Staff filed a motion to extend the deadline further on May 1, 2025. On May 5, 2025, Staff filed a *Motion for Extension* until May 7, 2025. The Commission granted both requests. On May 7, 2025, Staff filed a recommendation recommending the Commission deny the requests in the Application. On June 9, 2025, a pre-hearing conference was held requesting the parties to file either a Procedural Schedule or Status Report by June 16, 2025. Neither party filed a Procedural Schedule or a Status report, so the Commission ordered they be filed no later than Monday, July 7, 2025. On July 7, 2025 Staff filed a Status Report asking that they be granted until July 15, 2025 to file a response to the Commission. On July 15, 2025, Evergy filed a status report requesting until July 22, 2025 to file a response. On July 22, 2025, Evergy filed a status report which is a request for an extension of time requesting until July 29, 2025 to file a unanimous settlement and corresponding tariffs. The Commission will grant Staff and Evergy until July 29, 2025 to file the settlement and tariffs.

THE COMMISSION ORDERS THAT:

1. The parties shall file a settlement and tariffs by July 29, 2025.
2. This order is effective when issued.
