On July 13, 2020, Spire Missouri, Inc. (Spire), filed the above-referenced application. The application seeks, among other things, permission and approval and a certificate of convenience and necessity ("CCN") to construct, install, own, operate, maintain, and otherwise control and manage a natural gas distribution system to provide gas service in Cass County, Missouri, as a further expansion of the Company's existing certificated area.

The Commission granted the application on September 16, 2020. As ordered, Spire filed a tariff to reflect its new service territory. The Commission will order its Staff to file a Recommendation regarding that tariff, which is denominated Tariff No. YG-2021-0063.

#### THE COMMISSION ORDERS THAT:

- 1. The Staff of the Commission shall file a Recommendation regarding Spire's tariff no later than September 25, 2020.
- 2. Any objections to the Staff Recommendation shall be file no later than September 29, 2020.
