On July 13, 2020, Spire Missouri, Inc. (Spire), filed the above-referenced application. The application seeks, among other things, permission and approval and a certificate of convenience and necessity ("CCN") to construct, install, own, operate, maintain, and otherwise control and manage a natural gas distribution system to provide gas service in Cass County, Missouri, as a further expansion of the Company's existing certificated area.

The Commission granted the application on September 16, 2020. As ordered, Spire filed a tariff to reflect its new service territory. The Commission will order its Staff to file a Recommendation regarding that tariff, which is denominated Tariff No. YG-2021-0063.

THE COMMISSION ORDERS THAT:

1. The Staff of the Commission shall file a Recommendation regarding Spire's tariff no later than September 25, 2020.
2. Any objections to the Staff Recommendation shall be file no later than September 29, 2020.

3. This order shall be effective when issued.
