On September 17, 2020, the Staff of the Commission filed a Motion for Extension of Time. Liberty Utilities (Midstates Natural Gas Corp.) (Liberty) has filed Tariff No. JG-2021-0042 and Tariff No. YG-2021-0050 in this file. Staff's Recommendations were due on September 18, 2020. In its motion, Staff states that as of September 17, 2020, Liberty has not yet provided Staff with its supplemental data request response containing the information that Staff needs. Staff asks that the Commission make the Recommendations for both tariffs due on September 25, 2020.
