ORDER DIRECTING EXPEDITED RESPONSES TO THE MOTION TO STRIKE

This file involves prudence reviews of both Evergy Metro, Inc. and Evergy Missouri West, Inc. (referenced together as “Evergy”).¹ On September 21, 2020, Evergy filed its motion to strike portions of rebuttal testimony filed by the Office of the Public Counsel’s (Public Counsel) witness, Dr. Geoff Marke. On September 22, 2020, Public Counsel responded to Evergy’s motion.

Commission Rules allow ten days to respond to filings, unless otherwise ordered. The only party that has not yet responded to Evergy’s motion is the Staff of the Missouri Public Service Commission (Staff). In order to give the Commission time to review this dispute without, or before, disrupting the procedural schedule, the Commission will direct Staff to file an expedited response to Evergy’s motion.

THE COMMISSION ORDERS THAT:

1. Staff shall file a response to Evergy’s motion no later than noon on September 25, 2020.
