Staff began its ninth fuel adjustment clause (FAC) prudence review for Evergy Missouri West, Inc. d/b/a Every Missouri West and Evergy Missouri Metro, Inc. d/b/a Evergy Missouri Metro (collectively "Evergy") on March 3, 2020, in File Nos. EO-2020-0262 and EO-2020-0263. On August 28, 2020, Staff filed its *Staff's Ninth Prudence Review Report* in those files. The Sierra Club and the Office of the Public Counsel each filed a request for hearing. On September 10, 2020, Evergy filed a request to consolidate the files and to set a procedural schedule.

The parties met via video and telephone in a procedural conference on September 21, 2020, and discussed consolidation. As these files have substantially similar questions of law and fact, none of the parties present were opposed to the consolidation of the files. Additionally, the parties continued discussions of the appropriate procedural schedule off-the-record. The Commission will consolidate the files and direct the parties to file a proposed procedural schedule as set out below.

THE COMMISSION ORDERS THAT:

- 1. File Nos. EO-2020-0262 and EO-2020-0263 are consolidated for all purposes with File No. EO-2020-0262 being the lead case.
- 2. The parties shall jointly or separately file a proposed procedural schedule no later than October 5, 2020.
 - 3. This order is effective when issued.
