ORDER EXTENDING THE TIME FOR RESPONSES TO THE RECONCILIATION FILED PURSUANT TO SECTION 393.424.4, RSMo

On September 11, 2020, The Commission ordered The Empire District Electric Company (Empire) to file a reconciliation regarding the dollar value and rate or charge impact of the contested issues decided by the Commission in this rate case, as required by Section 386.420.4, RSMo. Empire was to file the reconciliation no later than September 21, and other parties were given until September 25 to respond to the reconciliation.

After discussions with the Commission's Staff, Empire filed an amended reconciliation on September 24. On September 25, Staff filed a response to the amended reconciliation. So that other parties may have adequate time to review the amended reconciliation and respond, the Commission will extend the time for responses to the reconciliation.

THE COMMISSION ORDERS THAT:

1. Any party wishing to file a response to Empire's amended reconciliation or Staff's response shall do so no later than October 2, 2020.
2. This order is effective when issued.
