Empire was to file the reconciliation no later than September 21, and other parties were given until September 25 to respond to the reconciliation.

After discussions with the Commission's Staff, Empire filed an amended reconciliation on September 24. On September 25, Staff filed a response to the amended reconciliation. So that other parties may have adequate time to review the amended reconciliation and respond, the Commission will extend the time for responses to the reconciliation.
