ORDER APPROVING TARIFF

Issue Date: September 30, 2020

Effective Date: October 15, 2020

On April 17, 2020, The Empire District Electric Company (Liberty-Empire) filed a Tariff No. YE-2020-0182 to implement a community solar pilot program.¹ Liberty-Empire requested and received multiple extensions of that tariff, and Liberty-Empire withdrew that tariff on September 15. Also on September 15, Liberty-Empire filed Tariff No. YE-2021-0062, which bears an effective date of October 15. This new tariff reflected conversations Staff has had with Liberty-Empire, as well as the company's recent name change.

Liberty-Empire plans to initially build an approximately 2.25 MW solar facility (4,500 solar blocks of 500 kW each) for the solar program. The solar program seeks to meet a need for customers wanting to purchase renewable energy and meet environmental goals they are not able to meet through currently available programs. Liberty-Empire intends for the program to satisfy the \$3.5 million utility-owned solar investment required by Section 393.1665.2 RSMo.

The Commission's Staff filed a recommendation regarding the tariff on September 22, 2020. Staff recommends that the Commission approve the tariff. Staff further explains that a certificate of convenience and necessity for this solar program is not required under Section 393.1665.2 RSMo. Staff's Recommendation states that Liberty-Empire will apply for a CCN for future solar builds. The Office of the Public Counsel offered its support of Staff's Recommendation on September 24. No party objected to Staff's Recommendation.

Staff recommends the Commission approve the tariff. The Commission will do so.
