ORDER APPROVING TARIFF

On September 16, 2020, Spire Missouri, Inc. (Spire) filed a tariff sheet under Tariff Tracking No. YG-2021-0063 in compliance with the Commission's *Order Granting Certificate of Convenience and Necessity* issued on September 16, 2020. Spire filed a substitute tariff on September 17, 2020. The submitted tariff sheet bears a proposed effective date of October 16, 2020.

On September 22, 2020, the Commission's Staff filed a recommendation that the Commission approve the compliance tariffs. The Commission gave parties until September 29, 2020 to object. The Commission received no objections. Because the tariff is unopposed, and so that this compliance tariff may go into effect expeditiously on the requested effective date, the Commission will make this order effective in less than thirty days.

The Commission has reviewed the tariff filing and Staff's recommendation and concludes that the tariff sheet should be approved.

THE COMMISSION ORDERS THAT:

1. The tariff sheet filed by Spire Missouri, Inc. on September 16, 2020, as substituted on September 17 2020, and given Tariff Tracking No. YG-2021-0063, is approved to become effective on October 16, 2020.
2. This order shall become effective on October 16, 2020.
3. This file shall be closed on October 17, 2020.
