ORDER PROVIDING FOR CORRECTION TO ADMITTED AND FILED EXHIBITS

On September 24, 2020, the Commission conducted an evidentiary hearing in Barbara Edwards' complaint against Evergy Missouri West, Inc. d/b/a Evergy Missouri West (Evergy West). On September 28, 2020, the Commission issued an order concerning post-hearing briefs and the filing of new exhibits, which were not identified and disclosed before the hearing.

Consistent with the Commission's August 6, 2020 procedural order, the parties on September 22, 2020, filed copies of all proposed exhibits. The pre-hearing disclosure enabled the parties and the presiding officer to review the proposed exhibits while maintaining physical distance during the hearing to avoid the transmission of COVID-19. In addition, during the September 24 hearing, the parties agreed that two additional exhibits should be admitted to the record: Complainant's Exhibit No. 14 and Evergy West's Exhibit No. 104. Complainant's Exhibit No. 14 was admitted by reference to the
