ORDER SUSPENDING TARIFF

On September 30, 2020, Spire Missouri Inc. d/b/a Spire filed tariffs that would modify its Commercial and Industrial rebate program language. The tariffs bear an effective date of October 30, 2020.

On October 6, 2020, the Staff of the Commission filed a Motion to Suspend Tariff Sheets. Staff explains that it believes that the Commission and other stakeholders may have an interest in these tariffs. Staff asks the Commission to suspend these tariffs, and further states it will file a Recommendation as soon as possible.

The Commission will suspend the tariffs. The Commission will also order its Staff to file a Recommendation.

THE COMMISSION ORDERS THAT:

1. The tariff sheets assigned Tracking Nos. JG-2021-0090 and JG-2021-0091 are suspended until December 30, 2020.
2. The Staff of the Commission shall file its Recommendation or alternative pleading no later than November 16, 2020.
3. This order shall be effective when issued.
