## CERTIFICATE TO PROVIDE TELECOMMUNICATIONS SERVICE

Issue Date: October 6, 2020

Effective Date: October 30, 2020

On September 30, 2020, A NET, L.L.C. filed an application for authorization to provide non-switched local telecommunications service and interexchange telecommunications service in exchanges statewide in the State of Missouri, as permitted by Sections 392.611.4 and 392.550, RSMo (2016). Additionally, A NET requested waiver of the Commission's sixty-day notice of case filing requirement.

The Commission has reviewed the application filed by A NET and finds that it and its attached affidavit comply with the filing requirements set forth in Section 392.550, RSMo (2016).

The Commission will grant A NET's request for waiver of the sixty-day case filing notice requirement under 20 CSR 4240-4.017. The Commission finds good cause exists for waiver based on A NET's verified declaration that it had no communication with the Commission regarding substantive issues likely to arise in this file within 150 days before filing its application.

Pursuant to 392.550.3, RSMo (2016), this order shall be effective in less than thirty days.

**THE COMMISSION ORDERS THAT:**

1. The sixty-day notice of case filing requirement is waived for good cause found pursuant to 20 CSR 4240-4.017(1)(D).
2. A NET, L.L.C. is granted authority to provide non-switched local telecommunications service in the exchanges set forth in the affidavit attached to the application and restated above.
3. A NET, L.L.C. is granted authority to provide interexchange telecommunications service in the exchanges set forth in the affidavit attached to the application and restated above.
4. This order shall become effective on October 30, 2020.
4. This file may be closed on November 2, 2020.
