## ORDER RECOGNIZING NAME CHANGE

Issue Date: October 7, 2020

Effective Date: October 27, 2020

DCT Telecom Group, Inc. submitted a letter dated September 1, 2020, advising that it wishes to change its name to DCT Telecom Group, LLC d/b/a Momentum Telecom of Ohio. The company subsequently filed an updated tariff to reflect the new name. That tariff carries an effective date of October 27, 2020. The Commission's Staff filed a recommendation on October 6, 2020, indicating the company has complied with all statutory and regulatory requirements for changing its name. Staff recommends the Commission recognize the name change and allow the updated tariff to take effect by operation of law. The Commission will do so.

### THE COMMISSION ORDERS THAT:

1. The Commission recognizes the name change of DCT Telecom Group, Inc. to DCT Telecom Group, LLC d/b/a Momentum Telecom of Ohio.
2. The revised tariff filed by DCT Telecom Group, LLC d/b/a Momentum Telecom of Ohio, (Tariff No. YX-2021-0085) will be allowed to take effect on October 27, 2020.
3. This order shall be effective on October 27, 2020.

4. This file shall be closed on October 28, 2020.
