## ORDER GRANTING APPLICATIONS TO INTERVENE

Union Electric Company d/b/a Ameren Missouri filed its 2020 Integrated Resource Plan (IRP) on September 27, 2020.<sup>1</sup> On September 29, the Midwest Energy Consumers Group (MECG) and Renew Missouri Advocates d/b/a Renew Missouri (Renew Missouri) filed separate applications to intervene. More than ten days have passed since MECG and Renew Missouri applied to intervene and no party has responded to either application.<sup>2</sup>

Commission Rule 20 CSR 4240-2.075(3) provides that the Commission may grant a motion to intervene if it finds that the proposed intervenor has an interest that differs from that of the general public and that may be adversely affected by the final order arising from the case, or if granting the proposed intervention would serve the public interest. The Commission finds that allowing MECG and Renew Missouri to participate in the review of Ameren Missouri's IRP will serve the public interest. The Commission will grant both applications to intervene.

### THE COMMISSION ORDERS THAT:

1. The Application to Intervene of MECG is granted.
2. The Application to Intervene of Renew Missouri is granted.
