On September 21, 2020, Union Electric Company d/b/a Ameren Missouri (Ameren Missouri) filed an application for approval of a Surge Protection Program. Contemporaneously therewith, Ameren Missouri filed an implementing tariff, which bears an effective date of December 20, 2020.

The Commission directed notice of the pending tariff and application, and allowed until October 7, 2020 for intervention requests. The Commission received no intervention requests, so the Commission will now order a Staff Recommendation.

THE COMMISSION ORDERS THAT:

1. The Staff of the Commission shall file a Recommendation or alternative pleading no later than November 10, 2020.
2. This order shall be effective when issued.
