**MOTION FOR LEAVE TO FILE REBUTTAL TESTIMONY PENDING RULING ON  
APPLICATION TO INTERVENE OUT-OF TIME**

**COMES NOW** Union Electric Company d/b/a Ameren Missouri ("Ameren Missouri" or the "Company"), and seeks leave to file rebuttal testimony from two Company witnesses, pending a Commission ruling on its above-referenced Application ("Application to Intervene") and, as reasons therefore, states as follows:

1. Ameren Missouri filed its Application to Intervene on July 15, 2025. The Commission has not yet ruled on the Application to Intervene. As required by Commission rule, the Company certified that it accepts the record established in this case to-date and the requirements of prior orders issued by the Commission in this docket.

2. One of those prior orders is the Commission's May 13, 2025, *Order Setting Procedural Schedule*, which established a rebuttal testimony deadline of July 25, 2025.

3. To comply with that order and deadline, the Company has prepared and submitted via in EFIS, concurrently with the filing of this Motion, Rebuttal Testimony from Ajay K. Arora and Steve Wills.
