On October 9, 2020, the Staff of the Missouri Public Service Commission (Staff) filed its recommendation regarding Ameren Missouri's Actual Cost Adjustment filing. Staff expressed some comments, concerns, and recommendations which were set forth in the Reliability Analysis and Gas Supply Planning section, and also the Hedging section of Staff's memorandum. Thus, Staff has recommended the Commission order Ameren Missouri to respond within 45 days to Staff's comments, concerns, and recommendations included in the Staff's recommendation and memorandum.

The Commission will direct Ameren Missouri to respond.
