## ORDER DIRECTING SPIRE MISSOURI TO RESPOND TO COMMISSION ORDER

On August 4, 2020, Spire Missouri Inc. (Spire Missouri), filed applications and petitions requesting that the Commission authorize changes to the Spire Missouri East and Spire Missouri West Infrastructure System Replacement Surcharges. The Commission issued an order directing notice, setting an intervention deadline, directing the filing of Staff recommendations, setting time for responses, and suspending tariff sheets until December 2, 2020.

Pursuant to that order, Staff filed recommendations in both files on October 2, 2020. Ordered paragraph eleven of the Commission's order states:

11. Spire Missouri, Inc. shall respond to Commission Staff's recommendation and any other objections or recommendations no later than October 9, 2020.

Spire Missouri failed to timely respond to Staff's recommendations. The Commission will again order Spire Missouri to respond to Staff's recommendations.

- Spire Missouri shall respond to Staff's recommendations no later than
   October 16, 2020.
