## ORDER RECOGNIZING NAME CHANGE

Issue Date: October 15, 2020

Effective Date: October 16, 2020

Steelville Telephone Exchange, Inc. submitted a letter dated October 6, 2020, advising that it has adopted the fictitious name STE Communications. The company subsequently filed an adoption notice tariff and title sheets to reflect the new name. That tariff carries an effective date of October 16, 2020. The Commission's Staff filed a recommendation on October 14, indicating the company has complied with all statutory and regulatory requirements for changing its name. Staff recommends the Commission recognize the name change and allow the updated tariff to take effect by operation of law. The Commission will do so.

### THE COMMISSION ORDERS THAT:

1. The Commission recognizes the adoption by Steelville Telephone Exchange, Inc. of the fictitious name STE Communications.
2. The revised tariff filed by STE Communication (Tariff No. YI-2021-0095) will be allowed to take effect on October 16, 2020.
3. This order shall be effective on October 16, 2020.

4. This file shall be closed on October 17, 2020.
