Steelville Long Distance Company, Inc. submitted a letter dated October 7, 2020, advising that it wishes to adopt the fictitious name STE Communications. The Commission's Staff filed a recommendation on October 15, 2020, indicating the company has complied with all statutory and regulatory requirements for changing its name. Staff recommends the Commission recognize the name change and allow the updated tariff to take effect by operation of law. The Commission will do so.
