ORDER RECOGNIZING NAME CHANGE

Effective Date: October 17, 2020

Steelville Long Distance Company, Inc. submitted a letter dated October 7, 2020, advising that it wishes to adopt the fictitious name STE Communications. STE Communications filed an updated tariff to reflect the new name. That tariff carries an effective date of October 17, 2020. The Commission's Staff filed a recommendation on October 15, 2020, indicating the company has complied with all statutory and regulatory requirements for changing its name. Staff recommends the Commission recognize the name change and allow the updated tariff to take effect by operation of law. The Commission will do so.

THE COMMISSION ORDERS THAT:

1. The Commission recognizes Steelville Long Distance Company, Inc.'s adoption of the fictitious name STE Communications.
2. The revised tariff filed by STE Communications (Tariff No. YX-2021-0096) will be allowed to take effect on October 17, 2020.
3. This order shall be effective on October 17, 2020.

4. This file shall be closed on October 18, 2020.
