On August 5, 2020, the Commission issued an order providing notice, directing filings, and suspending the tariff sheet revisions filed in this matter until December 2, 2020. On October 2, 2020, Staff filed its recommendations, and the Commission has received responses to the recommendation from the Office of the Public Counsel and Spire Missouri. No party fully agrees with Staff's recommendation, and no party has requested a hearing. The Commission will order a procedural conference to ascertain the direction of these cases.
