## ORDER DIRECTING THE PARTIES FILE A SETTLEMENT, A PROPOSED PROCEDURAL SCHEDULE, OR A STATUS REPORT

On October 20, 2020, a procedural conference was held to address how the above captioned matters will proceed. Spire Missouri Inc. d/b/a Spire, the Commission's Staff, the Office of the Public Counsel, and the Missouri School Board's Association attended the procedural conference. The regulatory judge expressed concern that limited time remained to accommodate an evidentiary hearing and briefs prior to obligatory Commission action, and no party has yet requested an evidentiary hearing. The parties stated that no hearing was requested because the parties are working toward a settlement. The parties expressed that they could file a settlement or a proposed procedural schedule on October 23, 2020, and would only need additional time if they were close to completing a settlement. The Commission will order the parties to file a settlement, a proposed procedural schedule, or status report stating the amount of additional time needed for settlement by October 23, 2020.

**THE COMMISSION ORDERS THAT:**

1. The parties shall file a settlement, a proposed procedural schedule, or a status report stating the amount of additional time needed for a settlement no later than October 23, 2020.
2. This order is effective when issued.
