ORDER DIRECTING EXPEDITED STAFF RECOMMENDATION AND SETTING TIME FOR RESPONSES

On October 16, 2020, Union Electric Company d/b/a Ameren Missouri filed a tariff sheet to reflect changes in the company's Purchased Gas Adjustment clause. These revisions reflect an adjustment to the Regular Purchased Gas Adjustment factor. The tariff sheet bears an effective date of November 1, 2020.

In consideration of the effective date of the tariff sheets, the Commission will direct the Staff of the Missouri Public Service Commission (Staff) to file a recommendation on an expedited schedule.

THE COMMISSION ORDERS THAT:

1. No later than October 26, 2020, Staff shall file a recommendation with regard to the tariff sheet filed by Union Electric Company d/b/a Ameren Missouri in Tariff File No. YG-2021-0098.
2. Any other entity wanting to comment on the tariff sheet shall do so no later than October 26, 2020.

3. This order shall be effective when issued.
