ORDER GRANTING VARIANCE

Issue Date: July 29, 2025

Effective Date: August 30, 2025

On May 29, 2025 Union Electric d/b/a Ameren Missouri (Ameren Missouri) filed an Application for approval of a variance regarding the timing of its monthly filings before the Commission. Ameren Missouri explains that new reporting requirements went into effect on April 1, 2025. While Ameren Missouri will continue to file its monthly generation reports under the requirements of 20 CSR 4240-3.190, Ameren Missouri requires additional time to set up a system to track the information under 20 CSR 4240-3.190(3)(A)4-6 and requires a variance from filing this specific information until such time a tracking system is in place. Ameren Missouri further requested a waiver of the Commission's 60-day notice rule, found at Commission Rule 20 CSR 4240-4.017.

The Commission directed Staff to file a recommendation by June 30, 2025 and Staff did so. The Commission set a deadline for responses to the application by June 30, 2025 and no responses were received.

Staff recommended that the waiver of the 60-day notice requirement of Rule 20 CSR 4240-4.017 be granted. Additionally, Staff recommends that the Commission grant

Ameren Missouri a variance to submit at a date no later than October 31, 2025, certain information accumulated from April 2025 to September 2025:

- Ancillary services for each generating unit (one of the reporting requirements of 20 CSR 4240-3.190(3)(A)4)); and
- Data requirements of 20 CSR 4240-3.190(3)(A)6.

Commission Rule 20 CSR 4240-3.190(11) allows the Commission to waive any provision of its Chapter 3 rules for good cause shown. After review of Ameren Missouri's application and Staff's Recommendation, the Commission finds good cause to waive the portions of the Chapter 3 rules in Ameren Missouri's application. The Commission will order a Ameren Missouri be granted a variance to submit information accumulated from April 2025 to September 2025 including Ancillary services for each generating unit required by 20 CSR 4240-3.190(3)(A)4 and Data requirements in 20 CSR 4240-3.190(3)(A)6.

Commission Rule 20 CSR 4240-4.017(1)(D) states that the Commission may grant a waiver from the Commission's rule requiring a 60-day notice before filing an application may be granted for good cause. Good cause exists in this case. Ameren Missouri has filed a verified declaration that it has had no communication with the office of the Commission within the prior 150 days regarding any substantive issue likely to be in this case, other than those pleadings filed for record. Accordingly, for good cause shown, the Commission waives the 60-day notice requirement of Commission Rule 20 CSR 4240-4.017(1).

THE COMMISSION ORDERS THAT:

1. Ameren Missouri shall be granted a waiver of the 60-day notice requirement.
2. Ameren Missouri shall be granted a variance to submit information accumulated from April 2025 to September 2025 including Ancillary services for each generating unit required by 20 CSR 4240-3.190(3)(A)4 and Data requirements in 20 CSR 4240-3.190(3)(A)6 no later than October 31, 2025.
3. This order shall be effective on August 30, 2025.
