**ORDER REGARDING OBJECTION TO CORRECTED STAFF REPORT**

On September 24, 2020, the Commission conducted an evidentiary hearing in Barbara Edwards' complaint against Evergy Missouri West, Inc. d/b/a Evergy Missouri West (Evergy West). On October 2, 2020, the Commission's data center filed exhibits offered during the hearing in the Commission's electronic filing and information system (EFIS). The Commission directed the parties to submit any corrections by no later than October 23, 2020.

On October 23, 2020, Staff filed a "Corrected Exhibit 201," which is labeled a "Corrected Report of the Staff." The corrected report is a revision of Staff's initial report, filed in this case on April 27, 2020, and offered during the hearing on September 24, 2020, as Exhibit No. 201. During the hearing, Staff counsel offered witness testimony which included some corrections to the Staff report.

The Commission will now direct that any objection to admission of "Corrected Exhibit 201" as part of the record of this case be filed no later than November 6, 2020.

In addition, the Commission notifies the parties that the Commission proposes Staff's original "Report of the Staff," attached to the *Staff Report* filed on April 27, 2020, and offered as Exhibit No. 201 during the hearing, will be admitted to the record as Exhibit No. 201. The original report is useful to the Commission's understanding of the case and the investigation of the case by Staff. Any objection to admitting Exhibit No. 201, in addition to Corrected Exhibit No. 201, must be filed no later than November 6, 2020.

**THE COMMISSION ORDERS THAT:**

1. Any objection to admission of Corrected Exhibit No. 201 as part of the record of this case shall be filed no later than November 6, 2020.

2. Any objection to admission of Exhibit No. 201, in addition to Corrected Exhibit No. 201, as part of the record of this case shall be filed no later than November 6, 2020.
