On October 22, 2020, Steelville Long Distance Company, Inc., d/b/a STE Communications filed an application for authorization to provide basic local and non-switched local telecommunications service in exchanges statewide in the State of Missouri, as permitted by Sections 392.611.4 and 392.550, RSMo (2016).

The Commission has reviewed the application filed by STE Communications and finds that it and its attached affidavit comply with the filing requirements set forth in Section 392.550, RSMo (2016). Pursuant to 392.550.3, RSMo (2016), this order shall be effective in less than thirty days.

2. STE Communications is granted authority to provide non-switched local telecommunications service in the exchanges set forth in the affidavit attached to the application and restated above.

3. This order shall become effective on November 21, 2020.
