### STAFF TARIFF RECOMMENDATION

**COMES NOW** Staff of the Missouri Public Service Commission and for this Staff Tariff Recommendation respectfully states as follows:

- 1. On July 18, 2025, Union Electric Company d/b/a Ameren Missouri (Ameren Missouri) filed a tariff sheet, Tracking No. JE-2026-0007, to correct a typographical error. That tariff sheet bears an effective date of August 14, 2025.<sup>1</sup>
- 2. On July 21, 2025, the Commission issued its *Order Directing a Staff Tariff Recommendation and Setting Time for Other Tariff Responses.* The Commission ordered Staff to file a recommendation addressing Ameren Missouri's error correction tariff sheet no later than July 31, 2025.
  - 3. In its accompanying tariff filing letter, Ameren Missouri stated:
    - This revision corrects an inadvertent typographical error in the Rate 3M Large General Service Customer Charge rate applicable to winter billing months. No customers have been billed under the erroneous rate, and this change will ensure that all customers are billed in accordance with the Stipulation and Agreement approved by the Commission in File No. ER-2024-0319.
- 4. Staff has reviewed the tariff sheet filed in Tariff Tracking No. JE-2026-0007 and recommends the Commission approve it with an effective date of August 17, 2025, as requested by Ameren Missouri.
