**NOTICE OF CLOSING AND  
MOTION TO CANCEL CERTIFICATE AND TARIFF**

COMES NOW Savannah Heights Industrial Treatment, Inc. (Savannah Heights), and, as its Notice of Closing and Motion to Cancel Certificate and Tariff, states as follows to the Missouri Public Service Commission's (Commission):

1. On December 6, 2007, the Commission issued its Order Approving Proposed Sale and Transfer of Sewer Utility Assets. Among other things the Order directed as follows:


Once the sale and transfer are complete, Savannah Heights Industrial Treatment, Inc. shall, within three business days, file a notice in this case informing the Commission of the completion of the transactions. At that time, Savannah Heights Industrial Treatment, Inc. shall also file a motion seeking a Commission order canceling the certificate of convenience and necessity currently held by Savannah Heights and canceling the associated sewer tariff currently on file, which is Tariff No. JS-2002-0071.

2. The sales and transfers that were the subject of this case were completed on December 17, 2007.

3. Accordingly, Savannah Heights hereby moves the Commission to cancel Savannah Heights' certificate (Case No. SA-98-294) and its tariff (JS-2002-0071).

WHEREFORE, Savannah Heights respectfully requests that the Commission issue its order cancelling Savannah Heights' certificate and tariff.


