While ATXI did not hold a meeting with the agencies prior to selection of the final route, a meeting between ATXI, their Natural Resources and Environmental Permitting Consultant AMEC Foster Wheeler, and the Natural Resource Agencies (Missouri Department of Conservation, Missouri Department of Natural Resources, United States Fish and Wildlife Services, and the Kansas City, Rock Island and St. Louis Regional Regulatory Branches of the United States Army Corps of Engineers) with a stake in determining relevant Environmental Permitting requirements for the Mark Twain Transmission Line, was held on April 8, 2015, in Hannibal, Missouri. This meeting was coordinated with the MDC and USFWS pursuant to the request identified above.


