FIRST AMENDED APPLICATION

COMES NOW Union Electric Company, d/b/a Ameren Missouri, ("Ameren Missouri" or "Applicant"), by and through its counsel, and, as its Application pursuant to §393.170, RSMo (2000), 4 CSR 240-2.060 and 4 CSR 240-3.205, for a certificate of convenience and necessity ("CCN") for a natural gas service area and line certificate, respectfully states as follows:

- 1. Ameren Missouri is a corporation in good standing, duly organized and existing under and by virtue of the laws of the State of Missouri, with its principal office and place of business at One Ameren Plaza, 1901 Chouteau Avenue, St. Louis, Missouri 63103. There is already on file with the Missouri Public Service Commission ("Commission") a certified copy of the Applicant's Certificate of Corporate Good Standing (*see* Case No. EO-2012-0085), and the Applicant's Fictitious Name Registration as filed with the Missouri Secretary of State's office (*see* Case No. EN-2011-0069), and said documents are incorporated herein and made a part hereof for all purposes.
- 2. The Applicant is engaged in providing electric and gas utility services in portions of Missouri as a public utility under the jurisdiction of this Commission. Other than cases that have been docketed at the Commission, Ameren Missouri has no pending actions or final unsatisfied judgments or decisions against it from any state or federal court or agency within the past three (3) years which involve customer service or rates. Company does, however, have a

number of cases pending before the Commission and various appellate courts of the State of Missouri. A list of those cases is attached to this application as **Appendix A** and is incorporated herein by reference. The Applicant has no annual reports or assessment fees that are overdue.

3. All correspondence, communications, notices, orders and decisions of the Commission with respect to this matter should be sent to the undersigned counsel

SUMMARY

4. Ameren Missouri proposes to construct, install, own, operate, control, manage and maintain a natural gas distribution system and gas transmission line to provide natural gas service in Boone County, Missouri, between Columbia and Ashland, as an expansion of its existing territory. Ameren Missouri requests both a line certificate and an area certificate pertaining to this expansion.

AREA TO BE CERTIFICATED

5. A legal description of the area to be certificated is attached hereto as **Appendix B**. A map depicting the proposed area of the certificate is attached to this Application as **Appendix** C.

TRANSMISSION LINE ROUTE

6. A depiction of the route of construction of the line is found on Amended

Appendix C. The line will start near Columbia in area currently certificated to Ameren

Missouri. The route of the new gas line is anticipated to generally follow easements obtained from property owners on the east side of Highway 63. The line will terminate in area near Ashland, Misosuri currently certificated to Ameren Missouri. The precise location of the proposed line will not be established until the referenced easements have been obtained. The

line will not cross any railroad tracks. However, depending on the final location, the line may cross underground facilities belonging to the following entities, as determined by an inquiry to Missouri One Call:

PROJECT INFORMATION

- 7. Ameren Missouri seeks to strengthen the reliability of the service provided to its natural gas customers in Ashland, Missouri. Ashland is currently served by a four inch steel line from Jefferson City. During cold weather periods, this existing gas line approaches its maximum capacity. At the current rate of gas load growth in Ashland, this line will not provide the necessary gas pressure to maintain reliable service to Ameren Missouri's customers at some point in the future.
- 8. The proposed project includes the installation of a ten inch steel natural gas feeder line extending from Columbia, Missouri, to just north of Ashland. The decision to install the new gas main from Columbia, instead of from Jefferson City, was made based on an analysis of estimated costs. Also, Ameren Missouri expects there will be interest in having natural gas

service from residents and businesses along the extension route that have not previously had natural gas service available.

- 9. Attached hereto and marked as **Appendix D** is a feasibility study containing a description of the plans and specifications for the project, to include the estimated cost of construction and expenses during the first three years of operations. Ameren Missouri proposes to serve new customers using the rates, general terms and conditions of service found in Ameren Missouri's currently approved tariffs.
- 10. Ameren Missouri intends to finance this project though existing funds and indebtedness.
- 11. Construction methods will follow Ameren Missouri's customary standards and the rules of the Commission.
- 12. Attached hereto and marked as **Appendix E** is a list of ten persons who reside, or own land, within the proposed service area.
- 13. Ameren Missouri will not require any additional franchises or permits from municipalities, counties, or other authorities in connection with the proposed construction for this filing other than the usual and customary state highway, railroad and county road permits, which will be obtained prior to construction. A certified copy of the franchises for the City of Ashland, Missouri and the City of Columbia, Missouri are attached as **Appendix F** and **Appendix G**.
- 14. The construction of the proposed facility is necessary to strengthen reliability of service provided to customers in and around Ashland, Missouri. Further, the area in which Ameren Missouri is seeking to be certificated hereby already contains some development. Service from a natural gas supplier is not available in this area at the present time. Thus, there is no same or similar utility service, regulated or nonregulated, available in the area requested.

Ameren Missouri has the ability to provide service in this area by construction of the new facilities and Ameren Missouri believes that potential new customers should be afforded the opportunity to take service from Ameren Missouri if they so desire. These facts support a finding that a grant of this application is required by the public convenience and necessity.

WHEREFORE, Ameren Missouri requests an order from the Commission granting it a certificate of convenience and necessity to construct, install, own, operate, control, manage, and maintain a natural gas distribution system and gas transmission line for the provision of natural gas service to the public, as described above, in Boone County, Missouri.
