## NOTICE OF EXPIRATION OF VIDEO SERVICE AUTHORITY

Issue Date: August 5, 2025

On August 4, 2025, Green Hills Communications, Inc. notified the Commission that it has ceased to provide video service, has no video service customers, and seeks to cancel its video service authority. The Commission granted video service authority to Green Hills Communications in Case Nos. KA-2008-0056, KA-2016-0052, and KA-2016-0296.

Under Section 67.2685, RSMo (2016), Green Hills Communications' service authorization expired upon notice to the Commission that it will cease to provide video service under that authorization. The Commission acknowledges receipt of notice by Green Hills Communications that it has ceased to provide video service. The authorization has expired by operation of law and no further action by the Commission is required. This case may be closed.
