## ORDER CANCELING IVOIP REGISTRATION

On October 14, 2020, NuAccess Networks, Inc. notified the Commission that it wishes to cancel its authority to provide Voice over Internet Protocol (VoIP) service in Missouri. The Commission granted that Registration in File No. DA-2019-0349, on May 21, 2019.

The Commission directed its Staff to respond, and on October 29, 2020, Staff filed a recommendation advising the Commission to cancel NuAccess Networks, Inc.'s Registration.

The Commission has the authority to cancel a Registration pursuant to Section 392.410.5, RSMo, which states, in part, "[a]ny certificate of service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected."

Based on the company's request, and Staff's recommendation, the Commission finds that the Registration granted to NuAccess Networks, Inc. shall be canceled.

### THE COMMISSION ORDERS THAT:

1. The Registration to provide VoIP services granted to NuAccess Networks, Inc., in File Number DA-2019-0349, is canceled.

2. This order shall become effective on November 30, 2020.
3. This file may be closed on December 1, 2020.
