**ORDER DIRECTING STAFF FILE A CALCULATION OF
ISRS REVENUE REEQUIREMENTS**

On October 23, 2020, Spire Missouri Inc., the Staff of the Missouri Public Service Commission (Staff), and the Office of the Public Counsel (collectively “Signatories”) filed their *Unanimous Stipulation and Agreement* purporting to resolve the issues between the parties in both of the files. The *Unanimous Stipulation and Agreement* states that if the Commission orders additional evidence in support of the stipulation, the Signatories agree that Staff may submit into evidence a report demonstrating the calculation of the revenue requirements found in the stipulation. Thus, the Commission will order Staff to file a report demonstrating the calculation of the revenue requirements found in the stipulation.

THE COMMISSION ORDERS THAT:

1. Staff shall file a report demonstrating the calculation of the revenue requirements found in the *Unanimous Stipulation and Agreement* no later than November 2, 2020.

2. This order is effective when issued.
