ORDER GRANTING LEAVE TO LATE-FILE DECLARATION

On October 19, 2020, Union Electric Company d/b/a Ameren Missouri filed a motion to accept the late-filed declaration of Mark C. Burk. In support of its motion, Ameren Missouri states that at the time it filed the application it inadvertently omitted the declaration. Commission Rule 20 CSR 4240-2.080(13) provides that parties shall be allowed ten days from the date of filing in which to respond to any pleading unless otherwise ordered by the Commission. Ten days have elapsed, and no party has objected to Ameren Missouri's motion. Thus, the Commission will grant Ameren Missouri's request.

1. Ameren Missouri's *Motion to Accept Late-Filed Declaration of Mark C. Birk* is granted.
