## ORDER SUSPENDING PROCEDURAL SCHEDULE AND CANCELLING EVIDENTIARY HEARING

On September 29, 2020,<sup>1</sup> the Commission issued a Procedural Schedule Order. On November 5, the parties filed a Joint Motion to Suspend Procedural Schedule. They state they wish to suspend the Procedural Schedule until such time as a decision is rendered on a pending motion for summary determination. A motion for summary determination has been filed and fully briefed and is pending. The case is set for an evidentiary hearing on December 14. The parties state they have agreed the suspension may be lifted and new procedural dates established in the event summary determination is not granted. The Commission will grant the parties' joint request, suspend the procedural schedule and cancel the evidentiary hearing now scheduled for December 14, 2020.
