NOTICE THAT EMPIRE'S MOTION FOR VARIANCES SHALL BE ADDRESSED IN FILE NO. ER-2021-0097, AND NOTICE CLOSING THIS FILE

Issue Date: November 6, 2020

On October 1, 2020, The Empire District Electric Company (Empire) filed its *Motion for Variance and Notice of New FAC Charge Types*. On October 30, 2020, Empire filed an amended motion also requesting a variance from identical requirements in its tariff. Empire filed those motions in this case and in File No. ER-2021-0097, Empire's most recent FAC adjustment filing. Commission Rule 20 CSR 4240-20.090(8)(D)1A, required Empire, as the party proposing to include the new FAC charge, to make a filing in this rate case. This filing is so that the parties in the case approving the current FAC are on notice of the new charge.

This rate case is currently under appeal. The Commission is providing notice that Empire's motions for variances will be addressed in File No. ER-2021-0097, so that the appellate record in this rate case is not unnecessarily cluttered. Parties to this rate case are already parties in File No. ER-2021-0097, and so have notice of the motions. Accordingly, the Commission does not need to take any further action at this time and this file shall be closed.
