## ORDER GRANTING APPLICATIONS TO INTERVENE

Union Electric Company d/b/a Ameren Missouri filed its 2020 Integrated Resource Plan (IRP) on September 27, 2020.<sup>1</sup> On October 30, Dutchtown South Community Corporation, New Northside Missionary Baptist Church, Inc., Spire Missouri, Inc., Clean Grid Alliance, and the Missouri State Conference of the National Association for the Advancement of Colored People filed separate applications to intervene. More than ten days have passed and no party has responded to any of those applications.<sup>2</sup>

Commission Rule 20 CSR 4240-2.075(3) provides that the Commission may grant a motion to intervene if it finds that the proposed intervenor has an interest that differs from that of the general public and that may be adversely affected by the final order arising from the case, or if granting the proposed intervention would serve the public interest. The Commission finds that allowing each of these applicants to participate in the review of Ameren Missouri's IRP will serve the public interest. The Commission will grant each of the applications to intervene.

5. The application to intervene of the Missouri State Conference of the National Association for the Advancement of Colored People is granted.
