On November 6, 2020, Aptitude Internet, LLC filed an application for authorization to provide interexchange and non-switched local exchange telecommunications services in Farmington, Missouri, as permitted by Section 392.611.4, RSMo (2016) and Section 392.550, RSMo (2016).¹

The Commission has reviewed the application filed by Aptitude Internet, LLC, and finds that it and its attached affidavit comply with the filing requirements set forth in Section 392.550, RSMo (2016). Pursuant to 392.550.3, RSMo (2016), which requires approval no later than thirty days after the application was filed, this order shall be effective in less than thirty days.

THE COMMISSION ORDERS THAT:

1. Aptitude Internet, LLC is granted authority to provide interexchange telecommunications services in Farmington, Missouri.
2. Aptitude Internet, LLC is granted authority to provide non-switched local exchange telecommunications services in Farmington, Missouri.
3. This order shall be effective November 20, 2020.
