On October 27, 2020, Union Electric Company d/b/a Ameren Missouri filed its Application, Request for Variances, and Request for Accounting Authority along with two tariff sheets designed to implement an electrification pilot program. On November 3, 2020, Renew Missouri Advocates d/b/a Renew Missouri filed an application to intervene. Ten days have elapsed, and no party has objected to the application to intervene.¹ The application satisfies the requirements of Commission Rule 20 CSR 4240-2.075, and intervention will be granted.

THE COMMISSION ORDERS THAT:

1. Renew Missouri's application to intervene is granted.
2. This order is effective when issued.
