The Commission issued its *Order Approving PGA Tariff* on November 12, 2020. The tariff will become effective on November 16, 2020. The Commission issues this order to correct an error in that order. In both the order heading and Ordered Paragraph 1, the order erroneously references Tariff No. YG-2021-0109. The order should have referred to the date Tariff No. YG-2021-0108 was substituted, November 2, 2020, and made no mention to the other tracking number. Therefore, the Commission will correct this error.

THE COMMISSION ORDERS THAT:

1. The first sentence of Ordered Paragraph 1 of the *Order Approving PGA Tariff* issued on November 12, 2020, is corrected to state, "The tariff sheets assigned Tracking No. YG-2021-0108, as substituted on November 2, 2020, are approved on an interim basis and subject to refund, pending final Commission decisions in this file and in File No. GR-2020-0123."
2. This order shall be effective when issued.
