## ORDER DIRECTING NOTICE, SETTING INTERVENTION DEADLINE, AND DIRECTING STAFF RECOMMENDATION

On July 31, 2025, Evergy Metro, Inc. d/b/a Evergy Missouri Metro (Evergy) submitted direct testimony and a tariff designed to implement a true-up and adjustment under its Fuel and Purchased Power Adjustment Clause (FAC). Evergy requests that the Commission authorize a true-up adjustment and implement it under its FAC tariff. The proposed tariff has an effective date of October 1, 2025.

Under Commission Rule 20 CSR 4240-20.090(8)(F), the Staff of the Commission (Staff) must submit a recommendation regarding the proposed adjustments no later than thirty days after Evergy's filing. Within sixty days after receiving the proposed adjustment, the Commission must: (1) issue an interim rate adjustment; (2) allow the tariff sheets and adjustments to take effect without a Commission order; or (3) suspend the timeline to receive additional evidence or hold a hearing, if required. Accordingly, the Commission will issue notice, set an intervention deadline, and direct Staff to file a recommendation.

Commission Rule 20 CSR 4240-20.090(17)(A) provides that parties to the rate case in which the Commission established Evergy's fuel adjustment clause are automatically parties to these cases, without the necessity of having to apply for intervention. Therefore, the Commission acknowledges that the parties to File No. ER-2024-0189 are parties to these cases, and will direct its Data Center to add those parties to the service lists.

**THE COMMISSION ORDERS THAT:**

1. The Commission's Data Center shall serve a copy of this order upon the parties to Case No. ER-2024-0189.
2. The Commission's Data Center shall add all parties to Case No. ER-2024-0189 to the service lists for these cases.
3. Any person or entity wishing to intervene shall file an application to intervene no later than August 21, 2025. Any such filing shall be submitted through the Commission's electronic filing and information system (EFIS) or delivered to: Secretary, Missouri Public Service Commission, P.O. Box 360, Jefferson City, MO 65102-0360.
4. Staff shall file a recommendation regarding its examination and analysis of Ameren Missouri's tariff filing no later than August 31, 2025.
5. Any responses to Staff's recommendation or comments on Evergy's tariff filing are due no later than September 14, 2025.
6. The Commission's Data Center shall provide notice of this order to the county commission of each county in Evergy's service territory.
7. The Commission's Public Policy and Outreach Department shall make notice of this order available to the news media serving the residents of Evergy's service territory.

8. This order is effective when issued.
