## NOTICE OF ERRATA TO THE REBUTTAL TESTIMONY OF SHANA RAMIREZ

COMES NOW, the Data Center Coalition ("DCC") and for its *Notice of Errata to the Rebuttal Testimony of Shana Ramirez* states as follows:

- 1. On July 25, 2025, DCC submitted the Rebuttal Testimony of Shana Ramirez in the above-captioned proceeding.
- 2. On July 29, 2025, DCC received a data request ("DR") from Staff of the Missouri Public Service Commission ("Staff") regarding a statement on page four of Ms. Ramirez's testimony indicating that she would provide a comparison of Evergy's proposed financial security approach to peer utilities. Review of Staff's DR alerted DCC that it had inadvertently omitted a table containing comparisons between Evergy's financial security proposal and that of peer utilities from Ms. Ramirez's testimony. After conferring with Staff, DCC provides this Notice of Errata concurrently with its response to Staff's DR in order to provide the requested information and ensure that the same is included in the record of this proceeding for parties' reference.
- 3. In addition, upon reviewing her testimony, Ms. Ramirez discovered an error in her calculation of the Net Present Value ("NPV") to customers under Ms. Ramirez's proposed financial security recommendations as compared to Evergy's Application. Correction of this error results in slight changes to customers' estimated annual cost for electric service, the total amount of collateral required under Evergy's proposal, the NPV of Evergy's proposed collateral commitment

and the net present cost to customers under Ms. Ramirez's proposal. DCC will serve an updated workpaper supporting this calculation concurrently with the filling of this Notice of Errata.

4. Attached hereto is a redlined copy of Ms. Ramirez's testimony reflecting the

addition of the omitted table and corrections to the NPV calculation, as well as a full, clean copy

of Ms. Ramirez's corrected testimony.

5. DCC does not believe that submitting these corrections will prejudice any party's

ability to address Ms. Ramirez's testimony through surrebuttal testimony or at hearing.

WHEREFORE, DCC submits this Notice of Errata to the Missouri Public Service

Commission.
