**ORDER PROVIDING FOR CORRECTION TO

On November 12-13, 2020, the Commission conducted an evidentiary hearing in the application of Evergy Metro Inc. d/b/a Evergy Missouri Metro and Evergy Missouri West, Inc. d/b/a Evergy Missouri West (collectively “Evergy”) for an accounting authority order to govern costs and financial impacts associated with the COVID-19 pandemic.

Consistent with the Commission’s October 28, 2020 *Order Setting Hearing Date and Resuming Procedural Schedule*, the parties provided to the regulatory law judge and other parties proposed exhibit lists and pre-marked proposed exhibits before the hearing, with minimal exceptions. In addition, during the hearing, one additional exhibit was admitted to the record: Evergy’s Exhibit 10. After hearing, some parties filed “corrected” exhibits.

Including the addition of Exhibit 10 and “corrected” exhibits filed by some parties, the exhibits admitted to the record during the hearing are as follows:

Adjudication staff marked each exhibit, and on November 19, 2020, the Commission’s data center filed each of the marked exhibits specified above in the Commission’s electronic filing and information system (EFIS).

During the hearing, some parties offered corrections to proposed exhibits, particularly pre-filed testimony. The Commission will direct the filing of corrected testimony to clarify the record. Correction of pre-filed testimony avoids the necessity of cross-reference to the hearing transcript.

A correction to pre-filed testimony can be offered under this order by filing in EFIS corrected testimony that incorporates the corrections testified to at hearing.

Testimony offered as a correction in written form at hearing, such as Exhibit 202 above, requires no additional correction to clarify the record. Likewise, “corrected” exhibits 1, 100, 100C and 300 have been marked and filed under this order. All exhibits listed above are subject to objection, pursuant to this order, to verify the correct documents are marked and filed in EFIS in full.

**THE COMMISSION ORDERS THAT:**

1. Proposed corrections to the filed exhibits identified above, including corrections of pre-filed testimony, shall be filed no later than November 23, 2020. Such corrections shall be proposed by filing a statement of the basis of the correction with a copy of the proposed corrected exhibit attached to the filing.

2. Any response to any such proposed corrections shall be filed no later than November 30, 2020.

3. This order shall be effective when issued.
